## Honoring America's Veterans (HAV) Honor Our Heroes Competition OFFICIAL RULES

### 1. Eligibility:

- a) Contest time frame: Beginning Monday, June 12, 2023, and ending Friday, July 14, 2023, Visit <a href="https://www.HonoringAmericasVeterans.org">www.HonoringAmericasVeterans.org</a> to submit a nominee.
- b) Honor Our Heroes Nominee must be a legal resident of Arizona (proof of residency required).
- c) Active-duty members are not eligible.
- d) You must be 18 or older at the time of entry.
- e) Members of the HAV board, the Parade Committee, or their family members are not eligible to enter.

#### 2.. How to Enter and Win:

- a) Visit www.HonoringAmericasVeterans.org to enter and win.
- b) Enter all required fields, including but not limited to: your first and last name, your e-mail address, your phone number, nominee's first and last name; indicate by checking a box adjacent to the choices what era the nominee served in (war, conflict, etc.), the rank of the nominee, 200-350 words describing why you feel the nominee should become one of the Phoenix Veteran's Day Honoring Our Heroes Awardees. Once all required fields are filled in, click the submit button. Incomplete entries will be disqualified.
  - Information in the entry must not infringe any third party's intellectual property rights. It must not include bigotry, racism, hatred, or harm against any group or individual, nor discrimination based on race, gender, religion, nationality, disability, sexual orientation, or age. All entries must be non-defamatory.
  - The nominee must have an honorable discharge and no pending criminal charges.
- c) HAV/KTAR reserves the right to delay contest announcements due to breaking news or other unanticipated events.
- d) A panel of judges will select seven (7) winners based on the nomination submission's persuasive nature. Seven (7) winners will be chosen (one representing each of the seven wars/conflicts listed at <a href="https://www.honoringamericasveterans.org">www.honoringamericasveterans.org</a>). The nonprofit Honoring America's Veterans and the Phoenix Veteran's Day Parade Committee reserve the right to select more than or less than seven Grand Marshals as they deem necessary.

# 3. Prize(s): The following prize package(s) will be awarded:

- a) Seven Awardees will each receive the following:
  - i. Participation in the Phoenix Veterans Day Parade as a Veteran Grand Marshal at the Parade set for 11 a.m., Saturday, November 11, 2023.
  - ii. Honor and recognition through various venues, including media, website blogs, other stories, social media, etc.
  - iii. Additional events and mementos may be added.

- iv. Your participation in this promotion acknowledges your acceptance of these offerings.
- v. You agree to ensure your nominee can fully participate in the parade and supporting activities in Phoenix.

#### 4. How to Claim Prize(s):

- a) Winners will be notified once all entries have been reviewed and winners have been determined no later than August 11, 2023.
- b) Winners will have seven (7) days from the notification date to accept their honoree nomination.

- d) Nominee must provide a redacted DD214 upon notice of selection. Applicants without a valid DD 214 will be declined.
- e) Before any prize(s) will be awarded, you must provide the following:
  - i. DD 214 certifying your military service.
- f) HAV reserves the right to deny awarding the Prize if you fail to provide satisfactory identification, as determined by HAV discretion.
- g) All federal, state, and local taxes (including sales taxes) are your sole responsibility.
- h) Any additional costs relating to the prizes incurred due to accepting the awards are your sole responsibility as the winner (hotels, transportation to events, gratuities, parking, meals, etc.).
